



HEALTHIER AMERICA SUMMIT CALLS TO ACTION GOVERNORS, GOVERNMENT OFFICIALS, BUSINESS EXECUTIVES, HEALTH EXPERTS, MEDIA, AND COMMUNITY LEADERS

WASHINGTON, June 12, 2007 – The Healthier America Summit being held today at the Ronald Reagan Building and International Trade Center in Washington, DC, will focus on key public health issues including the impact of Americans' health on the U.S. economy and the nation's preparedness for a possible pandemic flu outbreak. The summit will bring together representatives from government, public health, health care, business, media, and community and faith-based organizations to discuss pressing public health issues. The event is hosted by the Trust for America's Health (TFAH) with support from the Robert Wood Johnson Foundation, The California Endowment, The Duke Endowment, and The Pew Charitable Trusts.

The event will feature the release of "A Vision of a Healthier America," which issues a "call to action" for Americans to make disease prevention and protection from public health threats national priorities. A broad range of organizations have signed-on in support of the document, including the American Public Health Association, Association of Professionals in Infection Control and Epidemiology, Association of Public Health Laboratories, Breast Cancer Fund, California Communities Against Toxics, Campaign for Tobacco-Free Kids, Center for Biosecurity of the University of Pittsburgh Medical Center, Center for Science in the Public Interest, Commonweal, Environmental Defense, Families in Search of Trust, HIV Medicine Association, Ingham County (MI) Health Department, Ministry to Improve Childhood & Adolescent Health, National Association of Chronic Disease Directors, National Association of County and City Health Officials, National Center for Healthy Housing, National Disease Clusters Alliance, Physicians for Social Responsibility, Robert Wood Johnson Foundation, The California Endowment, The New York Academy of Medicine, TFAH, and YMCA of America.

"America should strive to be the healthiest nation in the world," said Governor Lowell Weicker, Jr., former three-term U.S. Senator and Governor of Connecticut. "This should be a nation where every American has the opportunity to be as healthy as he or she can be; where every community is safe from threats to its health; where all Americans have a high level of services that protect, promote, and preserve their health, regardless of who they are or where they live. This meeting underscores how much we will need every American to work together be part of the solution."

The Healthier America vision states: "our nation must strengthen America's public health system in order to: 1) provide people with the information and resources they need to make healthier choices and live healthier lives, and 2) protect people from health threats beyond their control, such as bioterrorism, natural disasters, and infectious disease outbreaks. "
